

NCTS Services

NCTS may finance the cost of your tutors until payment is made by the ASP program.

North Coast Tutoring Services is an approved State of Ohio ASP Provider. Our services are delivered in your home by qualified ABA and/or academic tutors. Fingerprinting and a records check by the Ohio Bureau of Investigation are required of all tutors. In addition, you and the tutors sign an adult supervision policy stating that a responsible adult will be present at all times when your tutors are in your home.

NCTS offers two programs for your children:

- ABA, Verbal and/or RDI plan
- NCTS Academic plan is appropriate for all other children



NCES Fees

NCES fees are added to each hour of tutoring. You may pay these fees yourself or they may be included in the cost billed to the Ohio ASP program. The NCTS financial agreement states that you are responsible for payment of NCES invoices, and that, if we are financing the cost of your tutors, you will pay NCES invoices immediately when you are reimbursed by the ASP program. We require a small deposit when you engage NCTS to provide ASP services.

Steps to apply for, and continue to receive, ASP funding.

Step 1

You apply for the ASP using the application form, and submit it with an IEP and a W-9 IRS form.

Step 2

NCTS meeting to explain services, ASP reporting and payment procedures. NCTS will pay your tutors every two weeks on a scheduled basis.

Set up the program with NCTS

- Develop curriculum – academic plan only
- Assist with tutoring budget
- Interview and hire tutor(s)
- Explain family responsibilities
- Review required paperwork
- Develop IEP Progress Report

Step 3

Managing the program

- State of Ohio – Statement of Costs
- School district – IEP progress reports, etc.
- NCTS – payment procedures, tutor changes, tutor payroll

Step 4

NCTS becomes a continuing resource for your family. We provide technical support, and help you resolve problems if they arise.

Autism Scholarship Program For Children With Autism Spectrum Disorder

In 2004, the State of Ohio created an exciting and innovative scholarship program for Autism Spectrum Disorder (ASD) children. The program reimburses families for approved services for as much as \$7,000 per calendar quarter and \$20,000 per year. The State operates on a fiscal year, July 1st through June 30th, and reimburses families at the end of each quarter.

To qualify for ASP funding, you must meet the following requirements:

- ✓ An ASD diagnosis for your child
- ✓ An existing IEP (Individual Education Plan)
- ✓ Child NO LONGER attending public school
- ✓ An approved ASP provider for services

Note: ASP is not a need-based program
